Charges are calculated by the second and are billed to your residual credit. National text messages are charged at $\notin 0.29$ /SMS. Text messages to EU countries are charged at $\notin 0.07$ /SMS. Text messages to non-EU countries are charged at $\notin 0.29$ /SMS and $\notin 0.99$ for 1 GigaData per day.

Monthly fee costs include activation fee of i-message service for compatible devices.
